

Right of Withdrawal

(Consumer is any natural person who concludes a legal transaction for purposes that predominantly neither their commercial nor their self-employed professional activity can be attributed.)

Right of withdrawal

You have the right to withdraw from this contract within fourteen days without giving any reason

The cancellation period is fourteen days from the day,

- on which you or a third party designated by you, who is not the carrier, deliver the goods in have taken possession of one or more goods as part of a have ordered a single order and this will be delivered in a single order;

- on which you or a third party named by you, who is not the carrier, left the last goods have taken possession of, if you have several goods in one have placed a single order and these are delivered separately;

To meet the cancellation deadline, it is sufficient that you send the notification of the exercise of the Submit the right of cancellation before the cancellation period has expired.

Consequences of revocation

If you revoke this contract, we will owe you all payments that we receive from you received, including the cost of delivery (excluding the additional costs that result from the fact that you have chosen a different type of delivery than that offered by us, have chosen the cheapest standard delivery), immediately and at the latest within fourteen days from the day on which the notification of your withdrawal of this contract has been received by us. This does not apply to goods for hygienic reasons have to be specially cleaned, here we reserve the right to do so to keep a flat-rate fee for cleaning. For this repayment we use the same means of payment that you used in the original transaction, unless because something else was expressly agreed with you; in no case will you charged for this repayment.

We can refuse the repayment until we have received the goods back or until you have provided proof that you have returned the goods, depending whichever is earlier.

You have to return the goods immediately and in any case within fourteen days at the latest the day on which you inform us about the revocation of this contract send back or hand over to us. The deadline is met if you return the goods at the end of the fourteen-day period.

You bear the direct costs of returning the goods.

You only have to pay for any diminished value of the goods if this Depreciation on a to check the nature, characteristics and functioning of the Goods not necessary handling them is due.

Reasons for exclusion or expiration

The right of withdrawal does not apply to contracts

- for the delivery of goods that are not prefabricated and for their manufacture individual selection or determination by the consumer is decisive or the are clearly tailored to the personal needs of the consumer;
- for the delivery of goods that can spoil quickly or whose expiry date is fast would be exceeded;

The right of withdrawal expires prematurely for contracts

- for the delivery of sealed goods for reasons of health protection or Hygiene are not suitable for return if their seal after delivery was removed;
- for the delivery of goods if these after delivery due to their nature inseparably mixed with other goods;
